

Wags & Barks Rules and Regulations

Health: All dogs must be in good health and free of any condition that could jeopardize the health of other dogs. Dogs who have been ill with a communicable condition in the last 30 days will require a letter from your veterinarian stating that the dog is in good health to be admitted or readmitted. Any communicable disease acquired by your dog must be reported to Wags & Barks, LLC.

Vaccinations: All dogs must have up-to-date vaccinations or titers. Owners need to submit written verification of this. We will provide a vaccination waiver if the owner has a letter from their veterinarian stating that the dog is on an alternative vaccination schedule for the health of the dog. Rabies vaccines are mandatory by the state and are REQUIRED. Puppies must be vaccinated for rabies by 6 months of age.

Fleas/Ticks: It is recommended that all dogs be on a flea/tick preventative such as Frontline or Sentinel (flea/tick collars are NOT allowed). If at any time a dog is noticed to have fleas or ticks, treatment will be applied and charged to the owner at a rate of \$25.

Nails: Dogs' nails must be kept trimmed for the safety of other dogs and staff. If nails are found to be excessively long or sharp, nails will be trimmed and charged to the owner at the current rate for a nail trim.

Age/Sex: There are no age restrictions/limits. Males over 9 months of age must be neutered. Females do not have to be spayed. However, they cannot attend day care when they are in season.

Food: Any food brought in must be in sealed containers with the dog's name on it. Food for Overnights must be divided into individual portions and labeled with the dog's name.

Behavior: All dogs must pass a behavior assessment for enrollment at Wags & Barks Doggy Day Care, LLC. Dogs must be non-aggressive and not food or toy protective. *Please remember that your pet will be spending time with other pets and that the safety and well being of all the dogs is our main priority.* Keep in mind, although play is supervised, that while playing with other dogs nips or scratches may occur.

Enrollment: All dogs must have a complete and up-to-date enrollment form and vaccination records on file. All required forms must be signed by owner prior to enrollment.

Fees: All fees must be paid at the end of each day. Multiple visit packages must be paid for in advance. Pre-paid packages are non-refundable.

Hours of Operation: Monday through Friday from 7:00 am to 6:00 pm. You may drop off and pick up your dog any time during these hours. A \$10 fee may be applied for habitual lateness.

Reservations/Cancellations: Reservations are recommended for Day Care, walk-ins are welcome based on available space. Reservations are REQUIRED for Over-Nights. Cancellations are acceptable with 24-hour notice. A fee of \$10 may be charged for No-show's and late cancellations.
