## **Wags & Barks Owner Agreement**

### **I acknowledge and agree to the following: (Please initial)**

\_\_\_\_ I understand that if my dog is not used to regular activity, they may experience sore muscles and sore feet. My dog may be tired and thirsty after daycare.

\_\_\_\_ My dog may get wet or dirty when at daycare.

\_\_\_\_ Excessively long toenails may cause injury. I will be notified if my dog's nails are too long. If, at my next visit, the nails have not been trimmed, they will be trimmed at my expense.

\_\_\_\_ My dog is up to date on vaccinations, specifically, Rabies, Distemper, Hepatitis, Parainfluenza, Parvovirus. Titters will be accepted.

\_\_\_\_ I understand that it is my responsibility to keep my dog up-to-date on vaccines, heartworm, flea/tick, and by not doing so puts my dog at risk of contracting these things and is not the fault of Wags & Barks.

\_\_\_\_ My dog is in good health and has not had a communicable disease in the last 30 days.

\_\_\_\_ My dog has not harmed or shown aggression towards any person or any other dog.

\_\_\_\_ I understand that any behavior from my dog that is deemed dangerous or inappropriate may result in dismissal from daycare.

\_\_\_\_ I understand that pictures will be taken of the facility, dogs, staff, and clients. These may be published on Wags & Barks website, in advertisements, at this facility, or by the media without my approval. I give Wags & Barks and persons authorized by Wags & Barks my consent and authorization, without compensation to me, to use, reproduce or alter the images in print or electronic format. All such images (prints, negatives, and copyrights) are the property of Wags & Barks Doggy Day Care, Inc.

\_\_\_\_ I recognize the risks involved in transportation due to emergency and agree to indemnify Wags & Barks Doggy Day Care, Inc, its members, staff, and volunteers for any injury, loss, liability, damage, or cost I may incur to my dog(s)

## **Wags & Barks Rules and Regulations**

**Health:** All dogs must be in good health and free of any condition that could jeopardize the health of other dogs. Dogs who have been ill with a communicable condition in the last 30 days will require a letter from your veterinarian stating that the dog is in good health to be admitted or readmitted. Any communicable disease acquired by your dog must be reported to Wags & Barks Doggy Daycare, Inc. immediately

**Vaccinations:** **All dogs must have up-to-date vaccinations or titers.** Owners need to submit written verification of this. We will provide a vaccination waiver if the owner has a letter from their veterinarian stating that the dog is on an alternative vaccination schedule for the health of the dog. Rabies vaccines are mandatory by the state and are REQUIRED. Puppies must be vaccinated for rabies by 6 months of age.

**Fleas/Ticks & Dewormer:** It is **recommended** that all dogs be on a flea/tick preventative as well as a dewormer. If at any time a dog is noticed to have fleas or ticks, treatment will be applied and charged to the owner plus the cost of exterminating our facility.

**Nails:** Dogs' nails must be kept trimmed for the safety of other dogs and staff. If nails are found to be excessively long or sharp, nails will be trimmed and charged to the owner at the current rate for a nail trim.

**Age/Sex:** There are no age restrictions/limits, however, if you are choosing to bring your puppy before the age of 16 weeks Wags & Barks Inc recommends discussing this choice with your vet so you are aware of the risks. **All dogs must be spayed/neutered by 12 months of age** (exceptions may apply). This is to limit the amount of aggression, marking, and accidental pregnancy.

**Food:** Any food brought in must be in sealed containers with the dog's name on it. Food for Overnights must be divided into individual portions and labeled with the dog's name.

**Behavior:** All dogs must pass a behavior assessment for enrollment at Wags & Barks Doggy Day Care, Inc. Dogs must be non-aggressive and not food or toy protective. **Please remember that your pet will be spending time with other pets and that the safety and well being of all the dogs is our main priority.** Keep in mind, although play is supervised, that while playing with other dogs, nips or scratches may occur.

**Enrollment:** All dogs must have a complete and up-to-date enrollment form and vaccination records on file. **All required forms must be signed by the owner prior to enrollment.**

**Fees:** **All fees must be paid at the end of each day.** Multiple visit packages must be paid for in advance. Pre-paid packages are non-refundable.

**Playgroups:** I understand that my dog, whether attending Wags & Barks Doggy Daycare Inc for daycare, grooming, or boarding, may be placed in a group with other dogs unless I request otherwise.

**Expulsion:** I understand that if my dog jumps the fence, putting themselves or other dogs in danger, they may be asked not to return. I also understand that anytime my dog may be asked not to return to Wags & Barks Doggy Daycare Inc due to behavior towards other dogs, staff, visitors, as well as destruction of property. This includes but is not limited to, fence jumping, fence fighting, causing fights, and or biting.

**Hours of Operation:** Monday through Friday from 7:00 am to 6:00 pm. Weekend drop off and pick up times for boarding are Saturday and Sunday 8-10 AM or 2-4 PM. Other accommodations might be available upon request. **A \$20 fee may be applied for habitual lateness of pickup past closing hours.**

**Reservations/Cancellations:** Reservations are recommended for Day Care, walk-ins are welcome based on available space. Reservations are REQUIRED for Over-Nights. Cancellations are acceptable with 24-hour notice. Wags and Barks reserves the right to refuse service to habitual no-show clients.
